# Global existence for semi-linear time fractional $\sigma$-evolution equations

#### Abstract

We investigate the global existence of small data solutions to the Cauchy problem for the semi-linear time fractional $\sigma$-evolution equation models with nonlinearity of derivative type and memory. Based on the Lr - Lq estimates obtained in linear problem, and combined with the global iteration method, the global existence of small data solutions is proved under certain conditions of power p. Furthermore, we find that in the low-dimensional case, the limit of our conclusion can match the critical exponent in classical results.

We investigate the global existence of small data solutions to the Cauchy problem for the semi-linear time fractional $\sigma$-evolution equation models with nonlinearity of derivative type and memory. Based on the $L^{r}-L^{q}$ estimates obtained in linear problem, and combined with the global iteration method, the global existence of small data solutions is proved under certain conditions of power $p$. Furthermore, we find that in the low-dimensional case, the limit of our conclusion can match the critical exponent in classical results.

## 1 | INTRODUCTION

In this paper, we consider the Cauchy problem for the semi-linear time fractional $\sigma$-evolution equations with nonlinearity of derivative type and memory in the following form

u(0, x)=u_{0}, \quad u_{t}(0, x)=u_{1}, \quad x \in \mathbb{R}^{n},
\end{array}\right.
$$

where $\alpha \in(0,1), \sigma>1, p>1$. The function $F\left(u_{t}\right)$ represents the power nonlinearities

\left|u_{t}\right|^{p} \quad \text { or } \quad \int_{0}^{t}(t-\tau)^{-\mu}\left|u_{t}(\tau, x)\right|^{p} d \tau
$$

for some $\mu \in(0,1)$. Here $\partial_{t}^{1+\alpha} u$ is the $1+\alpha$ order Caputo fractional derivative of $u(x, t)$ with respect to $t$, defined by

for any $j \in \mathbb{N}$, where

J_{0 \mid t}^{\beta} f(t)=\frac{1}{\Gamma(\beta)} \int_{0}^{t}(t-\tau)^{\beta-1} f(\tau) d \tau, \quad t>0

is the Riemann-Liouville fractional integral, defined for $\beta>0$, and $\Gamma(\beta)$ represents the Gamma function. The operator $(-\Delta)^{\sigma}$, is defined as follows

[^0]Fractional calculus has attracted a lot of attention and achieved considerable results over the past decades, it can describe the memory and inheritance of various material evolution processes, and reveal these properties neglected in integer calculus. This kind of equation (II) is evolved from the classical wave equation, which is obtained by substituting the second-order time derivative with the fractional derivative of $1+\alpha \in(1,2)$ in form, it is usually used to describe the propagation of mechanical waves in viscoelastic media with power-law characteristics and can describe the phenomenon between diffusion and wave propagation models. In recent years, many researchers ${ }^{1-4}$ have paid attention to the well-posedness of solutions of this kind of problems. However, as one might expect, when $\alpha$ decreases to zero in (II), the existence of the second data $u_{1}$ becomes unnatural, therefore we cannot let the range of $\alpha$ be too close to zero in this paper.

The Cauchy problem for classical wave equation with nonlinearity of derivative type has been studied by many scholars, and there are abundant results for the following form

Specifically, in the 1980s, Glassey ${ }^{5}$ proposed the conjecture that

$$
p_{G l a}(n)=1+\frac{2}{n-1}
$$

is the critical exponent for the Cauchy problem (4) , it means that in the supercritical case $p>p_{\text {Gla }}$, small data solutions exist globally, meanwhile the global solutions dose not exist under proper assumptions about initial data in the case of $p \leq p_{\text {Gla }}$. Kunio ${ }^{6}$ and Tzvetkov ${ }^{7}$ researched global existence and asymptotic behavior of solutions for general data as $p>p_{\text {Gla }}$, in the case of space dimension $n=2,3$, respectively. Sideris and Thomas ${ }^{8}$ studied global behavior of solutions in $n=3$ for radial data and Hidano et al ${ }^{9}$ proved existence of global solutions for all spatial dimensions. For higher dimension case $n \geq 4$, there are some results for blow up and estimation of life span in Zhou ${ }^{10}$ as $p \leq p_{\text {Gla }}$.

Recently, D'Abbicco et al ${ }^{4}$ studied the Cauchy problem for the following semi-linear time fractional diffusion-wave equation

\end{array}\right.

where $\alpha \in(0,1), p>1$, they found two critical exponents corresponding to the equations when the second data $u_{1}=0$ and $u_{1} \neq 0$, the two critical exponents are

$$
\tilde{p}=1+\frac{2}{n-2+2(1+\alpha)^{-1}} \quad \text { and } \quad \bar{p}=1+\frac{2}{n-2(1+\alpha)^{-1}}
$$

as we can see if $\alpha \rightarrow 0^{+}$, then $\tilde{p}$ tends to $1+2 / n$ which is the Fujita critical exponent. ${ }^{11}$ In addition, $\bar{p}$ tends to $1+2 /(n-1)$ found by Kato ${ }^{12}$ as $\alpha \rightarrow 1^{-}$, it is interesting that the problem (\$) can be related to the conclusion of the classical problems.

For the Cauchy problem of the semi-linear time fractional $\sigma$-evolution equation

u(0, x)=u_{0}, \quad u_{t}(0, x)=0, \quad x \in \mathbb{R}^{n},
\end{array}\right.
$$

where $\alpha \in(0,1), \sigma \geq 1, m \geq 0$ and $p>1$, Abdelatif and Michael ${ }^{2}$ considered the effect of the mass term on the global small data solutions, then Abdelatif ${ }^{1}$ took the case where the nonlinear term is

\int_{0}^{t}(t-\tau)^{-\mu}|u(\tau, \cdot)|^{p} d \tau
$$

for some $\mu \in(0,1)$, and also studied the influence of the mass term on this model.
Inspired by the works mentioned above, ${ }^{1,2,4,5}$ here we attempt to study semi-linear time fractional $\sigma$-evolution equation models with new nonlinearities $\left|u_{t}\right|^{p}$ and $\int_{0}^{t}(t-\tau)^{-\mu}\left|u_{t}(\tau, x)\right|^{p} d \tau$. Note that the second power nonlinearity is the RiemannLiouville fractional integral of $\left|u_{t}\right|^{p}$, and we remark that

thus, the Cauchy problem (II) with nonlinear memory term studied in this paper can be transformed into a classical problem of nonlinear term $\left|u_{t}\right|^{p}$ as $\mu \rightarrow 1^{-}$. It is of great significance to discuss the relationship between the properties of solutions of these two models.

Our main goal is to investigate the influence of the nonlinear terms on the global small data solutions and then compare their differences in the range of power $p$. The existence and uniqueness of global small data solutions to (II) may be proved by using global iterative methods based on the contraction mapping principle under certain conditions.

Here are some notations that will be used frequently.
Notation. We denote by $H^{s, p}$ the generalized Sobolev space

for any $s \geq 0$ and $p \in[1, \infty]$. Recall that $H^{s, p}=W^{s, p}$ if $s \in \mathbb{N}$, and denote the norm of homogeneous Sobolev space

We write $f \lesssim g$, implying that there exists a constant $C>0$, such that $f \leq C g$.
In addition, the notation

will be used throughout this paper.
Now our main results can be stated as follows.
Theorem 1.1. Assume that $\alpha \in(0,1)$ and $\sigma>\frac{1+\alpha}{2 \alpha}$. If $1 \leq n<\frac{2 \sigma \alpha}{1+\alpha}$ and the exponent $p$ satisfies the condition

where $\lambda \in\left(0, \frac{1+\alpha}{2 \sigma}\right)$. Then there exists a positive enough small constant $\varepsilon$ such that for any

to the Cauchy problem ( (Ш) with the nonlinear term $F\left(u_{t}\right)=\left|u_{t}\right|^{p}$. Moreover, for any $t \geq 0$, the solution satisfies the following estimates

Theorem 1.2. Assume that $\alpha \in(0,1)$ and $\sigma>\frac{1+\alpha}{2 \alpha}$. If $n \geq \frac{2 \sigma \alpha}{1+\alpha}$ and the exponent $p$ satisfies the condition

p>\bar{p}:=1+\frac{n(1+\alpha)}{2 \sigma \alpha} \tag{16}
\end{equation*}
$$

Then there exists a positive enough small constant $\varepsilon$ such that for any

the parameter $m>1$ is chosen as the solution to

with a sufficiently small constant $\delta>0$ ，that there exists a unique global solution

u \in C\left([0, \infty), \dot{H}^{k, m} \cap \dot{H}^{k, \infty}\right) \cap C^{1}\left([0, \infty), L^{m} \cap L^{\infty}\right) \tag{18}

to the Cauchy problem（ $(\mathbb{Z})$ with the nonlinear term $F\left(u_{t}\right)=\left|u_{t}\right|^{p}$ ．Moreover，for any $t \geq 0$ ，the solution satisfies the following estimates

Remark 1．1．The condition $\sigma>\frac{1+\alpha}{2 \alpha}$ determines that $\alpha$ can＇t be too small，otherwise problem（III）will be meaningless．If $\alpha \rightarrow 1^{-}, \sigma \rightarrow 1^{+}$，we can see that $\tilde{p} \rightarrow p_{G l a}(1)=\infty$ as $\lambda \rightarrow 1^{-}$and $n=1$ ，while $\bar{p} \rightarrow p_{G l a}(2)=3$ as $n=2$ ，when $n \geq 3, \bar{p}>p_{G l a}(n)$ ．In other words，the limit of our conclusion matches the critical exponent in the classical problem（4）for the low－dimensional case．
Theorem 1．3．Assume that $\alpha \in(0,1), \mu \in\left(\alpha-\frac{1+\alpha}{2 \sigma}, \alpha\right)$ and $\sigma>\frac{1+\alpha}{2 \alpha}$ ．If $1 \leq n<\frac{2 \sigma \alpha}{1+\alpha}$ and the exponent $p$ satisfies the condition

Theorem 1．4．Assume that $\alpha \in(0,1), \mu \in(\alpha, 1)$ and $\sigma>\frac{1+\alpha}{2 \alpha}$ ．If $n \geq \frac{2 \sigma \alpha}{1+\alpha}$ and the exponent $p$ satisfies the condition

to the Cauchy problem（Ш⿴囗十丌 ）with the nonlinear term $F\left(u_{t}\right)=\int_{0}^{t}(t-\tau)^{-\mu}\left|u_{t}(\tau, x)\right|^{p} d \tau$ ．Moreover，for any $t \geq 0$ ，the solution satisfies the following estimates

Remark 1.2. Compared with the homogeneous problem (see Remark 2.1) corresponding to problem (II), a loss of decay $(1+t)^{\alpha-\mu}$ occurs in regard to the estimates (24)-(25). In addition, $\overline{\bar{p}} \rightarrow \bar{p}$ as $\mu \rightarrow 1^{-}$, at this time the decay rate in (2प))-(B01) is the same as that in (II) $)$ (20).

## 2 | PRELIMINARIES

## 2.1 | Linear estimates

We first consider the linear problem corresponding to problem (II)

and introduce some useful lemmas before deriving the $L^{r}-L^{q}(1 \leq r \leq q \leq \infty)$ estimate of the linear problem (B1]).
Lemma $2.1\left({ }^{13}\right)$. Let $\alpha \in(0,1), b_{1}, b_{2}, \lambda \in \mathbb{R}$, then the following problem

y(t)=b_{1} E_{1+\alpha, 1}\left(\lambda t^{1+\alpha}\right)+b_{2} t E_{1+\alpha, 2}\left(\lambda t^{1+\alpha}\right)+\int_{0}^{t}(t-\tau)^{\alpha} E_{1+\alpha, 1+\alpha}\left(\lambda(t-\tau)^{1+\alpha}\right) f(\tau) d \tau \tag{33}

where $E_{1+\alpha, \beta}, \beta=1,2,1+\alpha$, are the Mittag-Leffler functions

For the linear problem (BI), by the Fourier transform in regard to $x$, we obtain

Thanks to Lemma 2.1, the solution to (31) is given by

& =\int_{0}^{\infty} \frac{s^{2 / \rho-\alpha}}{s^{2 / \rho}+2 \cos (\pi / \rho) s^{1 / \rho}+1}\left(\int_{0}^{\infty}\left(t r^{2 \sigma \rho}\right)^{1-\alpha} e^{-t s r^{2 \sigma \rho}} r^{n-1} \tilde{J}_{\frac{n}{2}-1}(r|x|) d r\right) d s  \tag{61}\\
& =\int_{0}^{\infty} \frac{s^{2 / \rho-\alpha}}{s^{2 / \rho}+2 \cos (\pi / \rho) s^{1 / \rho}+1}\left(F^{-1}\left(\left(t|\xi|^{2 \sigma \rho}\right)^{1-\alpha} e^{-t s|\xi| \xi^{2 \rho \rho}}\right)(t, x)\right) d s .

## 3 | PROOF OF THE GLOBAL EXISTENCE RESULTS

We first give a brief description of the global iteration method introduced by Li. ${ }^{17}$
For a given space $X$, it is equipped with a finite norm $\|\cdot\|_{X}$ related to the decay rates for the solution to (3ل]), then the global iteration method will be carried out through the following framework.

By (B5), a solution $u \in X$ to the linear problem (B1) satisfies the equality

Then local and global existence results are obtained simultaneously.

& \left\|\nabla^{k}(N u-N v)\right\|_{L^{q}} \lesssim(1+t)^{\alpha-\mu-\beta_{1, q}}\|u-v\|_{X}\left(\|u\|_{X}^{p-1}+\|v\|_{X}^{p-1}\right) \tag{122}
\end{align*}
$$

let $q=1, \infty$, respectively, (I2I) and (I22) lead to

$$
\begin{equation*}
\|\Phi u-\Phi v\|_{X}=\|N u-N v\|_{X} \lesssim\|u-v\|_{X}\left(\|u\|_{X}^{p-1}+\|v\|_{X}^{p-1}\right) . \tag{123}
\end{equation*}
$$

Then we may conclude a unique global solution

$$
\begin{equation*}
u \in C\left([0, \infty), \dot{H}^{k, 1} \cap \dot{H}^{k, \infty}\right) \cap C^{1}\left([0, \infty), L^{1} \cap L^{\infty}\right) \tag{124}
\end{equation*}
$$

The proof is completed.

## 3.4 | Proof of Theorem 1.4.

We now define the space

$$
\begin{equation*}
X=\left\{u \mid u \in C\left([0, \infty), \dot{H}^{k, m} \cap \dot{H}^{k, \infty}\right) \cap C^{1}\left([0, \infty), L^{m} \cap L^{\infty}\right),\|u\|_{X}<\tilde{M}\right\} \tag{125}
\end{equation*}
$$

with the norm

$$
\begin{align*}
\|u\|_{X}=\sup _{t \geq 0}(1+t)^{\mu-\alpha+\xi-1}\left\{\left\|u_{t}\right\|_{L^{m}}\right. & +(1+t)^{\beta_{m, \infty}}\left\|u_{t}\right\|_{L^{\infty}}  \tag{126}\\
& \left.+\|u\|_{\dot{H}^{k, m}}+(1+t)^{\beta_{m, \infty}}\|u\|_{\dot{H}^{k, \infty}}\right\}
\end{align*}
$$

where $\xi=\frac{(\alpha+1-\mu) p}{p-1}-\frac{n(1+\alpha)(p-m)}{2 \sigma m(p-1)}>0$, notice that $\xi<\alpha+1-\mu$ if and only if

$$
p>1+\frac{2 \sigma(1-\mu)+n(1+\alpha)}{2 \sigma \alpha}
$$

for sufficiently small $\delta \rightarrow 0^{+}$in (48).
For any $u \in X$, consider the following mapping

$$
\Psi: X \rightarrow X, \quad \Psi u:=u^{\operatorname{lin}}(t, x)+N u
$$

We shall prove that

$$
\begin{equation*}
\|\Psi u\|_{X} \lesssim\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{M}}+\|u\|_{X}^{p}, \tag{127}
\end{equation*}
$$

and

$$
\begin{equation*}
\|\Psi u-\Psi v\|_{X} \lesssim\|u-v\|_{X}\left(\|u\|_{X}^{p-1}+\|v\|_{X}^{p-1}\right) \tag{128}
\end{equation*}
$$

For the proof of ([27), according to the the estimate (50)), we have

$$
\begin{align*}
\left\|u^{\operatorname{lin}}\right\|_{X}=\sup _{t \geq 0}(1 & +t)^{\mu-\alpha+\xi-1}\left\{\left\|u_{t}^{\operatorname{lin}}\right\|_{L^{m}}+(1+t)^{\beta_{m, \infty}}\left\|u_{t}^{\operatorname{lin}}\right\|_{L^{\infty}}\right. \\
& \left.+\left\|u^{\operatorname{lin}}\right\|_{\dot{H}^{k, m}}+(1+t)^{\beta_{m, \infty}}\left\|u^{\operatorname{lin}}\right\|_{\dot{H}^{k, \infty}}\right\}  \tag{129}\\
& \lesssim\left\|\left(u_{0}, u_{1}\right)\right\|_{\mathcal{M}^{\prime}} .
\end{align*}
$$

It remains to prove that $\|N u\|_{X} \lesssim\|u\|_{X}^{p}$. If $u \in X$, then by interpolation one can get the following estimate

$$
\begin{equation*}
\left\|u_{t}\right\|_{L^{q}} \lesssim(1+t)^{\alpha+1-\mu-\xi-\beta_{m, q}}\|u\|_{X}, \quad q \in[m, \infty] . \tag{130}
\end{equation*}
$$

Consequently,

$$
\begin{align*}
\left\|\left|u_{t}(t, x)\right|^{p}\right\|_{L^{m}} \lesssim\left\|u_{t}(t, x)\right\|_{L^{m p}}^{p} & \lesssim(1+t)^{-\left(\mu-\alpha+\xi-1+\beta_{m, m p}\right) p}\|u\|_{X}^{p} \\
& \lesssim(1+t)^{-\left(\mu-\alpha+\xi-1+\beta_{m, p}\right) p}\|u\|_{X}^{p} . \tag{131}
\end{align*}
$$

due to $\beta_{m, m p}>\beta_{m, p}$, note that

$$
\begin{equation*}
0<\left(\mu-\alpha+\xi-1+\beta_{m, p}\right) p=\xi<\alpha+1-\mu<1 \tag{132}
\end{equation*}
$$

since $\mu>\alpha$.
For the nonlinear part of the solution, similar to the proof in Theorem 1.3, by taking $r=m$ in ([44) and ([55) and combine with (I31), then

$$
\begin{align*}
\left\|\left((N u)_{t}, \nabla^{k} N u\right)\right\|_{L^{q}} & \lesssim \int_{0}^{t}(t-\tau)^{\alpha-1-\beta_{m, q}}\|f(\tau, \cdot)\|_{L^{m}} d \tau \\
& \left.\lesssim \int_{0}^{t}(t-\tau)^{\alpha-1-\beta_{m, q}} \int_{0}^{\tau}(\tau-s)^{-\mu}\| \| u_{t}(s, x)\right|^{p} \|_{L^{m}} d s d \tau \\
& \lesssim \int_{0}^{t}(t-\tau)^{\alpha-1-\beta_{m, q}} \int_{0}^{\tau}(\tau-s)^{-\mu}(1+s)^{-\left(\mu-\alpha+\xi-1+\beta_{m, p}\right) p}\|u\|_{X}^{p} d s d \tau  \tag{133}\\
& \lesssim \int_{0}^{t}(t-\tau)^{\alpha-1-\beta_{m, q}}(1+\tau)^{-\mu+1-\xi} d \tau\|u\|_{X}^{p} \\
& \lesssim(1+t)^{\alpha+1-\mu-\xi-\beta_{m, q}}\|u\|_{X}^{p},
\end{align*}
$$

let $q=m, \infty$, respectively, thus

$$
\begin{equation*}
\|N u\|_{X} \lesssim\|u\|_{X}^{p} . \tag{134}
\end{equation*}
$$

Finally, it remains to show ([28). By Hölder's inequality, for $u, v \in X$,

$$
\begin{align*}
\left\|\left|u_{t}\right|^{p}-\left|v_{t}\right|^{p}\right\|_{L^{m}} & \lesssim\left\|\left|u_{t}-v_{t}\right|\left(\left|u_{t}\right|^{p-1}+\left|v_{t}\right|^{p-1}\right)\right\|_{L^{m}} \\
& \lesssim\left\|u_{t}-v_{t}\right\|_{L^{m p}}\left\|\left|u_{t}\right|^{p-1}+\left|v_{t}\right|^{p-1}\right\|_{L^{\frac{m p}{p p}}} \\
& \lesssim\left\|u_{t}-v_{t}\right\|_{L^{m p}}\left(\left\|u_{t}\right\|_{L^{m p}}^{p-1}+\left\|v_{t}\right\|_{L^{m p}}^{p-1}\right)  \tag{135}\\
& \lesssim(1+t)^{-\left(\mu-\alpha+\xi-1+\beta_{m, m p}\right) p}\|u-v\|_{X}\left(\|u\|_{X}^{p-1}+\|v\|_{X}^{p-1}\right) \\
& \lesssim(1+t)^{-\left(\mu-\alpha+\xi-1+\beta_{m, p}\right) p}\|u-v\|_{X}\left(\|u\|_{X}^{p-1}+\|v\|_{X}^{p-1}\right) .
\end{align*}
$$

Hence,

$$
\begin{align*}
\left\|(N u)_{t}-(N v)_{t}\right\|_{L^{q}} \lesssim(1+t)^{\alpha+1-\mu-\xi-\beta_{m, q}}\|u-v\|_{X}\left(\|u\|_{X}^{p-1}+\|v\|_{X}^{p-1}\right),  \tag{136}\\
\left\|\nabla^{k}(N u-N v)\right\|_{L^{q}} \lesssim(1+t)^{\alpha+1-\mu-\xi-\beta_{m, q}}\|u-v\|_{X}\left(\|u\|_{X}^{p-1}+\|v\|_{X}^{p-1}\right), \tag{137}
\end{align*}
$$

let $q=1, \infty$, respectively, ([136) and (IU37) lead to

$$
\begin{equation*}
\|\Phi u-\Phi v\|_{X}=\|N u-N v\|_{X} \lesssim\|u-v\|_{X}\left(\|u\|_{X}^{p-1}+\|v\|_{X}^{p-1}\right) . \tag{138}
\end{equation*}
$$

Then we may conclude a unique global solution

$$
\begin{equation*}
u \in C\left([0, \infty), \dot{H}^{k, 1} \cap \dot{H}^{k, \infty}\right) \cap C^{1}\left([0, \infty), L^{1} \cap L^{\infty}\right) \tag{139}
\end{equation*}
$$

The proof is completed.
